Braunstein and Honus Wagner Company, a corporation, their heirs,
executors, administrators, successors and assigns, as appears by
Order of Court dated December 28th, 1928, of Watson B. Adair, Esq.,
Referee in Bankruptcy of the District Court of the United States
for the Western District of Pennsylvania, made in the Matter of
The Honus Wagner Sporting Goods Company, a Delaware Corporation,
Bankrupt, at No. 14400 In Bankruptcy, and further as acknowledged

in the written agreement between John H. Wagner and E. L. Braunstein, to the said same effect, dated January 21st, 1929:
